Changes to the Constitution





Constitution

**The date in 13(a) of the Constitution be changed from
“ June 15th ” to “ June 30th ”**

Reason:

Paul Blackwell in Registration had received comments from a number of clubs that 15th June was too early in the season to prohibit transfers of players.

Changes to Match Rules

NB Under rule 11d of the Constitution, clubs will be voting to introduce changes to Match Rules on an experimental basis for one year. Such changes will then be put to next year's AGM for permanent adoption.





Match Rules – Duration

Duration

Rule 1 a) “Each match will start at 1.00pm.....”

Will replace “Each match will start at 1.30pm (1.00pm for divisions 1 & 2).....”

Reason:

The vote at the EGM was very close and many clubs suggested that the whole League should start at 1.00pm

Match Rules – Umpires (1)

Rule 8

The second sentence will have the following words added at the end of the sentence:

“.....who ideally would have attended and passed ECB-ACU training courses at level 1 or 1A with the intention that qualification would become mandatory for the 2012 season”

Reason:

Peter Hinstridge and the umpire's sub-committee are keen to improve the standard of umpiring throughout the League

Match Rules – Umpires (2)

Rule 8

Replace the third sentence with the following:

“Failure to do so will result in a 5 point penalty, except where the club had supplied at least one umpire more than the number of teams it has in divisions where panel umpires are provided (this includes HCPL divisions 1 and 2 East)”

Reason:

The old rule mitigated against clubs that had provided an umpire to the panel but did not have a team in a division where panel umpires were provided

Match Rules – Umpires Marking

Note:-The following paragraph is not a change to League match rules, therefore no vote is required:

Umpires marking

The Competitions Committee has decided that any proposed changes to the Rules and Playing Conditions for the County Cup and Trophy competitions should now be reviewed by the full Executive Committee. To that end, Cup and Trophy Rule 10.2 “within 48 hours” on page 77 of the Handbook and also “within 48 hours” in the last line on page 19 of the Umpires Panel section in the Handbook will be replaced by “by 11.00pm on the Monday after the game” to be consistent with the timing referenced in the 1st line of the Umpires marking section on page 31 of the Handbook.





Match Rules – 2009 Changes

2009 Match Rule Changes need to be ratified under rule 11d.

Duration:

Divisions 1 and 2 , matches to start at 1.00pm-*note this will not be necessary if the amendment to rule 1a) is carried.*

Points system:

**Batting points are doubled for the side batting first.
Also for the side batting second having lost the toss.**

In divisions 11-14, batting bonus points start at 110 runs(instead of 140)
