Results and Team Reporting by Captains

Use the Herts Cricket app to report match results and record players' names. Results can also reported via the League website. All results, including cancelled and abandoned games, and teams, are to be reported by 9.00pm on the day of the match.

It is the responsibility of all home XI captains to report the result by the required deadline and both teams should enter names of their own players. The home XI is the side that appears first in the fixture list in the League Handbook, regardless of where the game is played.
